Welcome Back, Cougar Nation!

I hope you had a **wonderful Spring Break** and are ready to **send your Cougars back to school on TUESDAY, March 21st**. We are now counting the days left of school & every child needs to be on time, daily. **Every minute of every school day is vital for your child to build upon the knowledge they already have and to learn the required standards needed to successfully complete their grade level.** <u>Here is our timeline</u>: 11 weeks left of school, 20 school days until 3-5 Reading STAAR, 25 school days until the 5th grade Science STAAR, and 29 school days until the 3-5 Math STAAR. *Keep in mind that STAAR testing is now done over a time frame therefore if a scholar is absent they still have to take the STAAR when they return to school.* Circle observables for PK begin April 17th and Circle testing is from May 1-19th. End of Year MAP testing K-5 is scheduled to begin May 15th. **Home visits for scholars who are absent and/or tardy often will be conducted in compliance with Texas compulsory attendance laws.** Please communicate with the main office if your child is absent and remember to send a Dr or hand written note within 48 hours of your child returning to school. Communication is key to paving a positive path for your child's success. We are here to help.

Safety is always our top priority and it takes ALL of us working in unison. Please do not let yourself into the building when you see an employee enter or exit the building. I witnessed this on Friday on our cameras before we left for Spring Break; this parent then held the door open for another adult to also enter Huppertz. AS ADULTS, PAUSE TO THINK ABOUT YOUR ACTIONS. Being part of the solution to keeping everyone safe means you ring the doorbell, wait for someone to answer, then state your name and why you are on campus. Even if an adult holds the door open for you and you have not spoken to someone on the doorbell camera, do not enter the building. You are encouraged to report unsafe behaviors such as these to me via my email <u>lriosgarcia@saisd.net</u> & I will promptly investigate and take appropriate action. **PLEASE** help keep our Cougars safe.
