- Responsibility of charter design committee come up with a design and strategies to meet campus challenges
- Background of current charter
 - Described partnership with Trinity and Core Knowledge
 - Trinity trained staff and compensated staff as well
 - Advantages of Core knowledge foundation
 - Core knowledge content based on global curriculum
 - Core Knowledge started before the charter
- Current Hawthorne Information
 - Enrollment = 745
 - 60 students are from outside the district
 - About 300 students reside outside of the Hawthorne Attendance boundaries
- Revoking charter would mean we would lose 300 400 students who do not reside in the Hawthorne attendance zone so revoking the charter would not be a good option.
- Renewal of charter
 - Purpose strong campus leaders making decisions at the campus level
 - More empowerment for campus without district managing decisions move and sustain
 - Caviat use new format to reflect a school
 - Improvement process
 - Challenges
 - Goals
 - Academic model how to respond and solve challenges (very challenging process)
 - Implement system for feedback and input
 - o Timeline began last year; revised charter is due by end of this school year
 - 5 out of 7 charter schools in SAISD are in the revision stage
 - Submit to SAISD Board of Trustees in May for approval
- SAISD Charter Info.
 - 24 in-district charters currently
 - Scheduled for May 2019
 - 2 revoked charters
 - 5 revised charters
 - 15 schools complete their proposals (14 using new legislation if a school is willing to partner with another entity money will be available for them)

- Hawthorne has met standard, but a concern now is the letter grade assigned to campuses based on performance
 - Hawthorne has received a "D" rating for the last school year.
