

# **Title I Briscoe Elementary Parent and Family Engagement Policy 2024-2025 School Year**

## **A. Policy Involvement**

### **Briscoe Elementary will:**

- Convene an annual meeting for all parents and family members to inform them of Briscoe's participation in the Title I program. The meeting will be held during the 1<sup>st</sup> nine weeks of the school year in the morning as part of the monthly Principal/Parent Coffee. The meeting is held in the library and is open to all families.
- Involve families in ongoing conversations about implementing Title I programs and initiatives on the campus. There will be opportunities for parent feedback to be gathered at the monthly principal coffees, PTA meetings, and CLT meetings.
- Provide parents with timely information about the meetings, including flyers and phone calls about upcoming events. Briscoe will also honor requests from the parents as to meeting times and dates, 9 informative sessions for the parents regarding the curriculum via individual student conferences as, and whole group sessions 9 needed. If the plan is not satisfactory to parents, the school will honor parent's comments and suggestions for improvement.

## **B. Shared Responsibilities for High Student Academic Achievement**

### **Briscoe Elementary will:**

- Create and utilize a School-Parent and Family Engagement Compact that outlines the role of the parents, family members, students, and staff in improving student academic achievement. The Family Engagement Specialist will distribute the school-parent surveys during registration and together with a committee that includes families, they will compile the data and feedback from the surveys to create a School and Family Engagement Compact for improving student academic achievement. This compact will be reviewed and revised throughout the school year at parent meetings and trainings when appropriate/needed.
- Solicit the input of parent through multiple meeting throughout the year to create, revise and evaluate the Parent and Family Engagement Policy.
- Provide multiple opportunities for parents to be involved with the living document that outlines all curriculum and programming at Briscoe known as the campus improvement plan. A parent representative will serve on the campus leadership team which is responsible for creating and revising the document.
- Information about assessments given to students in grades k-8<sup>th</sup> will be communicated with parents to help them better understand their child's needs. This information will be shared at Principals Coffees, Hands-on Workshops, Family Nights, and Meet the Teacher.

- Provide opportunities to educate parents and family members of the children at Briscoe Elementary about state academic standards and assessment criteria. Through family nights, Principal/Parent Coffees, and individual student conferences. Parents will be further educated on curricular standards and academic expectations in the state of Texas
